SALE TERMS: All horses must have a negative Coggins test within six (6) months of the presentation/sale, and a health certificate within 30 days of event. Current flu and rhino shots also required. Each consignment/presentation entry includes one stall and one bale of straw. All entry fees are non-refundable. COMMISSION: 8% of last bid (\$250 min, all sales over \$10,000 will be commissioned at 2%). NO SALE: Same as commission. WITHDRAWAL FEE: \$400. Original registration certificate will need to be presented at sale office before entry can be processed. Certificate **MUST** be in the current seller's name and transfer must be signed.

SALE AGREEMENT

When used herein, the CONSIGNOR shall include any person entering an animal or animals in any sale conducted herein, including the owner or his agent signing the reverse side of this agreement; and Mid-Atlantic Morgan Horse Sale LLC shall be referred to as MAMHS. By entering an animal or animals in any sale conducted by MAMHS, the consignor or his agent signing the reverse side of this agreement, the consignor does thereby agree to the following terms and conditions.

The consignor agrees that all animals shall be at the place of sale in proper time, delivered free of expense to MAMHS. The consignor agrees that after having consigned stock to the sale of MAMHS, he will not dispose of it by private sale, either prior or during the progress of sale. He also agrees that no animal will be withdrawn from the sale, except in case of injury or sickness, subsequent to the time of entry of sale, sufficient in nature to prevent realizing a fair price, and in case of withdraw of an animal without the consent of MAMHS, a \$400 withdrawal fee will be charged.

Consignor shall notify MAMHS within 24 hours if the horse develops a serious injury or serious disease after consignment which impairs its suitability for sale. Upon such occurrence, consignor shall make the request for withdrawal in writing as soon as practical after the onset of the condition, and consignor determines that the horse is not suitable for sale. Consignor shall provide an affidavit of a licensed veterinarian which (1) states the date the animal was first examined for the condition, (2) specifically identifies the condition of the animal, and (3) states an opinion to a reasonable degree of scientific and medical certainty that the animal is suffering from serious injury or serious disease which renders the horse unfit for transportation and sale. Consignor shall submit the request for withdrawal and veterinarian affidavit to MAMHS not later than 24 hours prior to commencement of sale session. The animals consigned to the MAMHS are entirely at the risk of the consignor until sold and fully paid for. The consignor is the responsible party, MAMHS acting only as the agent.

Consignor warrants title of each animal (including foals and foals in utero) free of any liens or encumbrances, and agrees to defend title against all claims. Consignor warrants all information set forth herein regarding pedigrees, identity, engagements, etc. Consignor warrants that no animal is being sent to MAMHS while suffering from any contagious disease, or is unsafe or vicious. Consignor acknowledges that consignor is solely responsible for all information provided herein.

Consignor agrees to indemnify and hold MAMHS harmless from all costs, claims or expenses incurred because of question to title, pedigree, physical condition, identity, or engagements resulting from claims against the animal or proceeds from the sale.

The registration certificate of each animal listed as registered must be furnished with a clear title of ownership by the consignor. The consignor authorizes MAMHS to act on his agent in the transfer of the registration certificate.

The consignor agrees that he will be present in person, or have a duly authorized representative present, to make true representations respecting each animal. In disputed cases involving the soundness of an animal

or statement by consignor, MAMHS will have the sole right to appoint an expert who shall decide the point at issue. The decision of the expert, and no other, shall be binding on both seller and buyer, and if the consignor is decided in wrong, he agrees to pay the examination fee, and that in case the animal is refused by a bidder on account of misrepresentation of the consignor or agent, and the refusal is sustained by the referee, he will pay the full commission.

MAMHS disclaims responsibility for errors and/or omissions by consignors or their agents and/or omissions in catalog.

All horses, including stallions being presented in the Stallion Presentation, must have a current health certificate within 30 days of sale date, a negative Coggins test within six (6) months of sale date, along with proof of flu and rhino shots to enter the PA Farm Show Complex.

TERMS OF COMMISSION & PAYMENT

1. A commission of 8% on the highest bid will be charged for all horses sold (\$250 minimum, all sales after \$10,000 will be commissioned at 2%).
2. For NO SALES, the consignor must pay 8% of the No Sale figure or final bid (\$250 minimum, all sales after \$10,000 will be commissioned at 2%).
3. Transfers will be deducted from consignor's account.
4. A minimum withdrawal fee of \$400 will be charged for all horses withdrawn from the sale, or any horses considered as "outs".
5. Sale proceeds will be mailed to the Owner/Consignor and made payable to same within 30 days of the close of sale.

IMPORTANT NOTICE: All **BRED** mares must be accompanied by a certificate signed by a certified veterinarian, dated within 30 DAYS prior to sale, stating whether or not the mare is in foal.

GELDING SHOWCASE CLASS INFORMATION:

On Tuesday morning at the sale, you will receive a leather halter with the gelding's name and pedigree on one side, and a 2026 Gelding Class Participant Plate on the other side.

GUIDELINES & SCHEDULE: All entries in this class must be presented in hand and hitched. **TUESDAY 1:00 PM:** all 4YO geldings will be presented in hand, followed by 5YO geldings. While 5YO geldings are being presented in hand, 4YO geldings need to prepare for being presented in harness in groups of 5 at a time. After 4YOs have been presented in harness, the 5YOs will be presented in the same manner. **WEDNESDAY 8 AM:** All 4YO geldings will be presented in groups of 5, with 5YO geldings to follow.
